

Fellowship Hall Usage Agreement

Rules & Clean Up

- Tables and chairs can be used but must be wiped down after use.
- Kitchen area may be used. Utensils/pans, etc. can be used from the kitchen. Any paper products used must either be replaced or items will need to be paid for and the church will purchase replacements. Notify any staff for replacement of paper products.
- Children should be kept out of sanctuary and basement. Bathrooms may be used in the newer building.
- No use of any of Solsberry Christian Church's electronic/audio/video devices unless other wised previously set up with church staff.
- The entire church property is a smoke and alcohol free zone. Any violation of this rule will result in immediate loss of deposit.
- Trash must be taken to dumpster in the back parking lot.
- Sweep and pick up any area that has been used.

Costs:

- Members Cost: \$0
- Fellowship Hall - \$100
 - A deposit of \$200 is to be paid 2 weeks prior to your event, after which, your deposit will be returned within 2 weeks assuming that no damage has been made to the property.
- Custodian Cost - \$100 (Optional)
 - If cleaning the facilities yourself, it must be done to the approval of a staff or church custodian.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in the _____ of Solsberry Christian Church ("Church"), I hereby release, waive, discharge and covenant not to sue the Church, its claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in the above referenced program or activity, or while in, on or upon the premises where the program or activity is being conducted, while in transit to or from the premises, or in any place or places connected with the Church.
2. I am fully aware of risks and hazards connected with being on the premises and participating in the Church program or event, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the program or event, and I hereby elect to voluntarily participate in the program or Event, to enter upon the above named premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the program or event, whether caused by the negligence of releasees or otherwise.
3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur due to my participation in the program or event, whether caused by the negligence of any or all of the releasees, or otherwise.
4. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a Release, Waiver, Discharge, and Covenant Not to Sue the above named releasees.

In signing this release, I acknowledge and represent that:

- A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;
- C. I am at least eighteen (18) years of age and fully competent; and
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
